

The nonpublic school also is required to provide information to the Maryland State Department of Education on the amount of non-BOOST financial aid received by the student for the 2023-2024 school year, and if the BOOST scholarship plus non-BOOST financial aid exceed the tuition amount owed, the BOOST scholarship will be reduced.
