Introduction

Annually, on December 1, the Maryland State Department of Education (MSDE) collects information on students with disabilities (ages 3-21) who reside in the State of Maryland. In order to be included in this count, the child must be identified as having a disability and receiving active special education services on December 1.

The Special Services Information System (SSIS) consists of two separate data collections. The first is the December 1 Census, a count of all students receiving special education services on December 1 of every year. Data on students who have exited special education are collected on June 30 of every year.

The SSIS database is used to compile information on Maryland students with disabilities. MSDE uses the SSIS database as:

- a source of information to meet its planning, monitoring, and accounting responsibilities for special education;
- a recording and reporting tool for decisions made by the Individualized Education Program (IEP) Team; and
- an instrument for federal reporting requirements.*

Definitions

Least Restrictive Environments

Out < 21% - students with disabilities enrolled in a comprehensive school who receive special education and related services *outside the general education classroom* for less than 21% of the school day.

Out 21-60% - students with disabilities enrolled in a comprehensive school who receive special education and related services *outside the general education classroom* for at least 21%, but no more than 60% of the school day.

Out > 60% - students with disabilities enrolled in a comprehensive school who receive special education and related services *outside the general education classroom* for more than 60% of the school day.

Homebound Placement - students with disabilities who receive more than 50% of instruction homebound.

Hospital Placement - students with disabilities who receive more than 50% of instruction in a hospital setting.

Public Separate Day School - students with disabilities who spend more than 50% of the school day in separate public facilities as day students.

Private Separate Day School - students with disabilities who spend more than 50% of the school day in separate private facilities as day students.

Public Residential Facility - public residential placement for students with disabilities.

Private Residential Facility or Center - private residential placement for students with disabilities.

Additional Preschool Least Restrictive Environments

Home - preschoolers with disabilities for whom it is appropriate to receive services at home, not single service.

Itinerant Setting - preschoolers with disabilities who receive only speech and/or language at a school or another location.

Reverse Mainstreaming - preschoolers with disabilities who receive special education in a class designed for students with disabilities where over 50% of the students are not disabled.

*Required by the Individuals with Disabilities Education Act (IDEA), as amended June 4, 1997 (PL 105-17) as well as reporting requirements for Title VI and Title IX of the Civil Rights Act, as the Titles apply to Special Education, and Section 504 of the Rehabilitation Act of 1973.

Early Childhood Setting – preschoolers with disabilities who receive all of their special education and related services in educational programs designed primarily for children without disabilities.

Early Childhood Special Education Setting – preschoolers with disabilities who receive all of their special education and related services in educational programs

designed primarily for children with disabilities housed in regular school buildings or other community based settings.

Part-Time Early Childhood Part-Time Early Childhood Special Education – preschoolers who receive services in multiple settings.

December 1, 2000

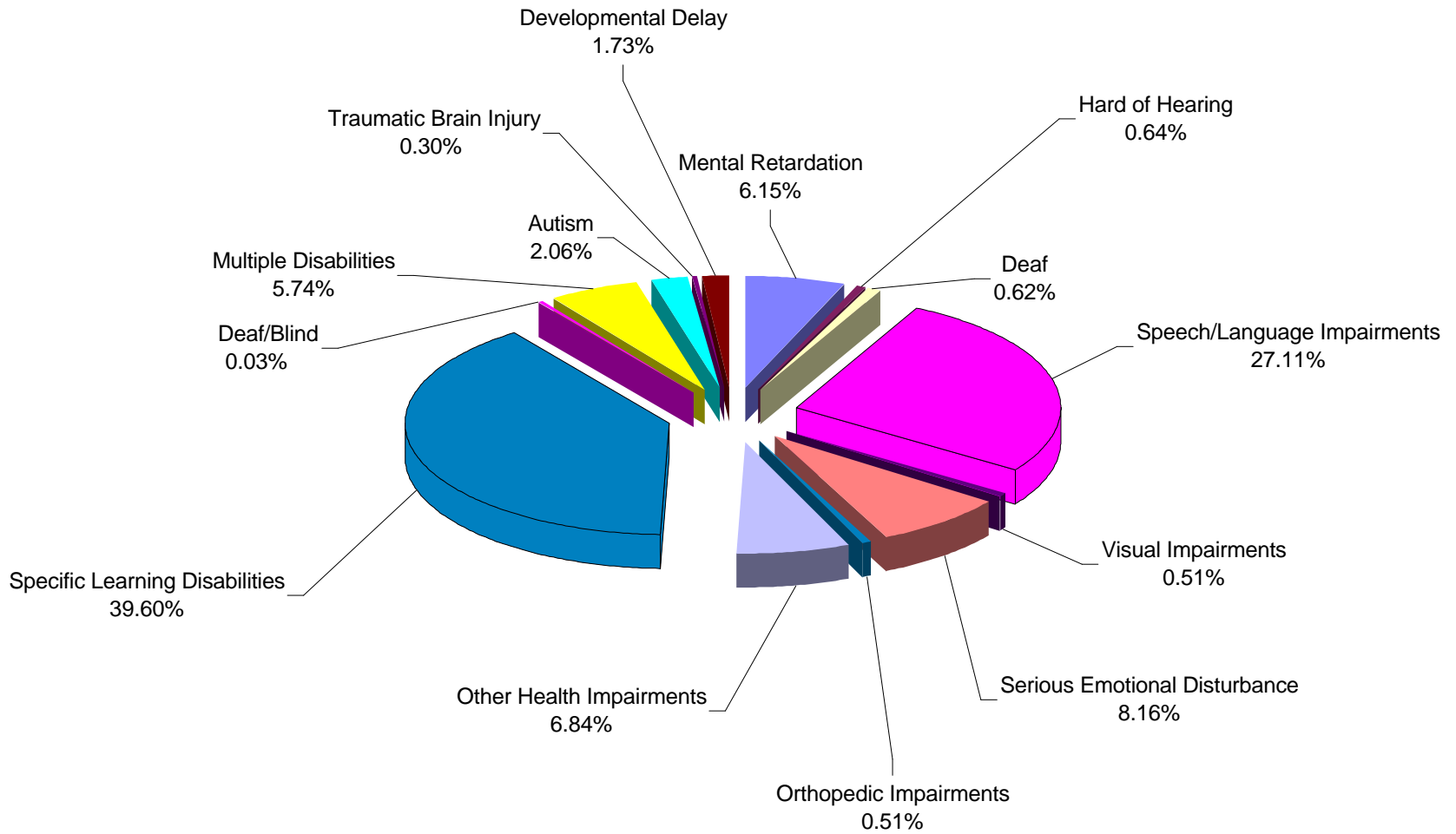

December 1, 2000

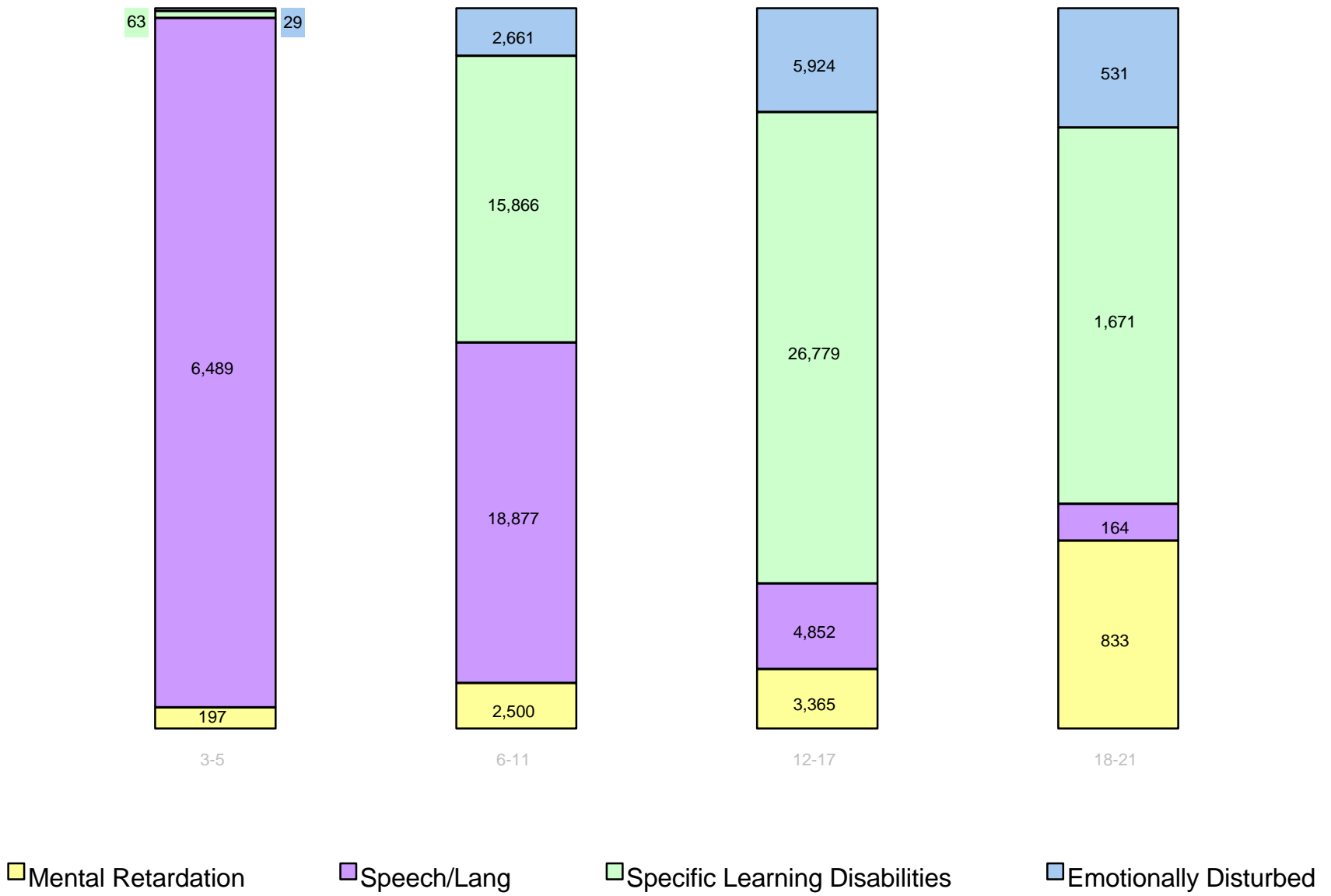

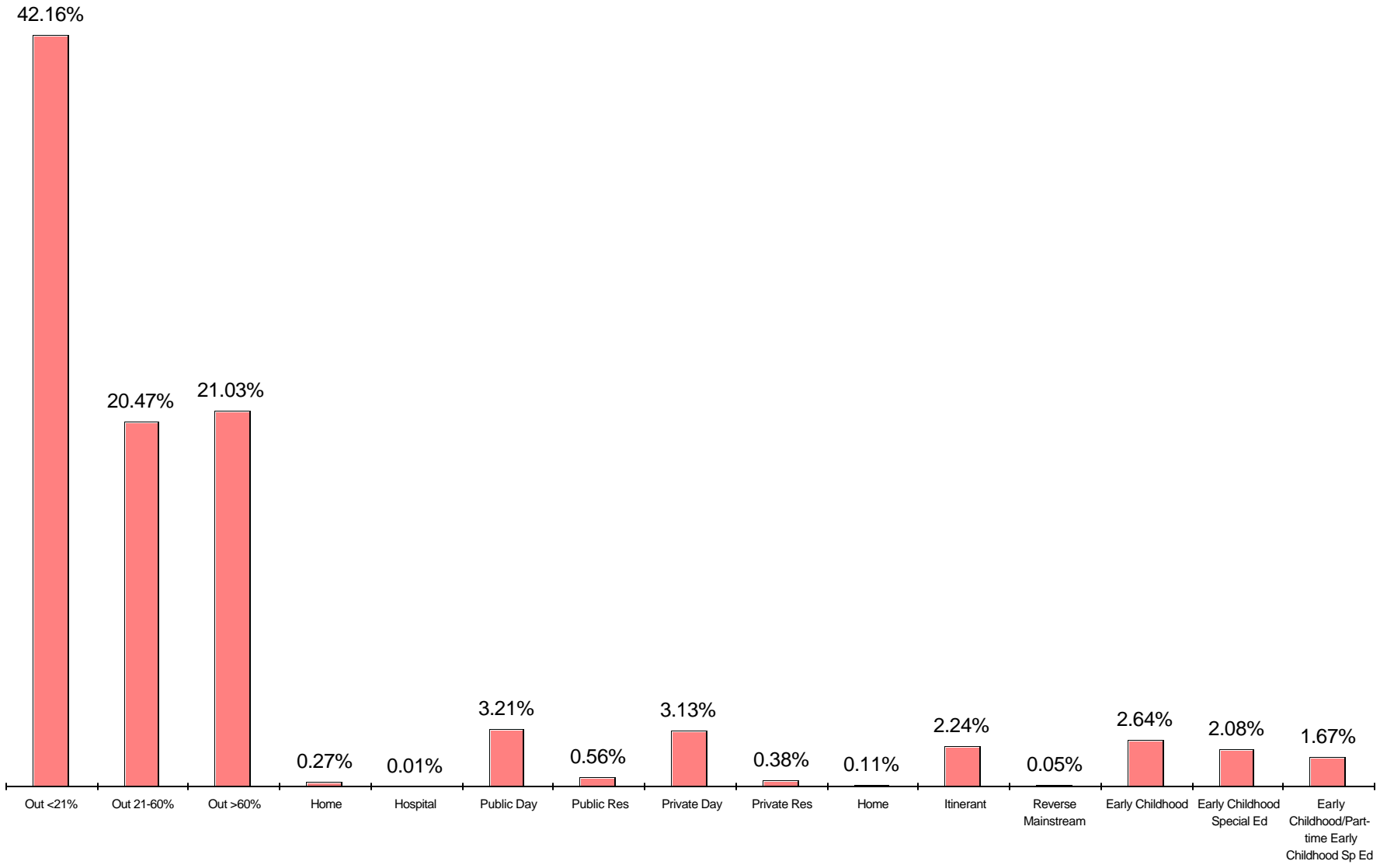

December 1, 2000

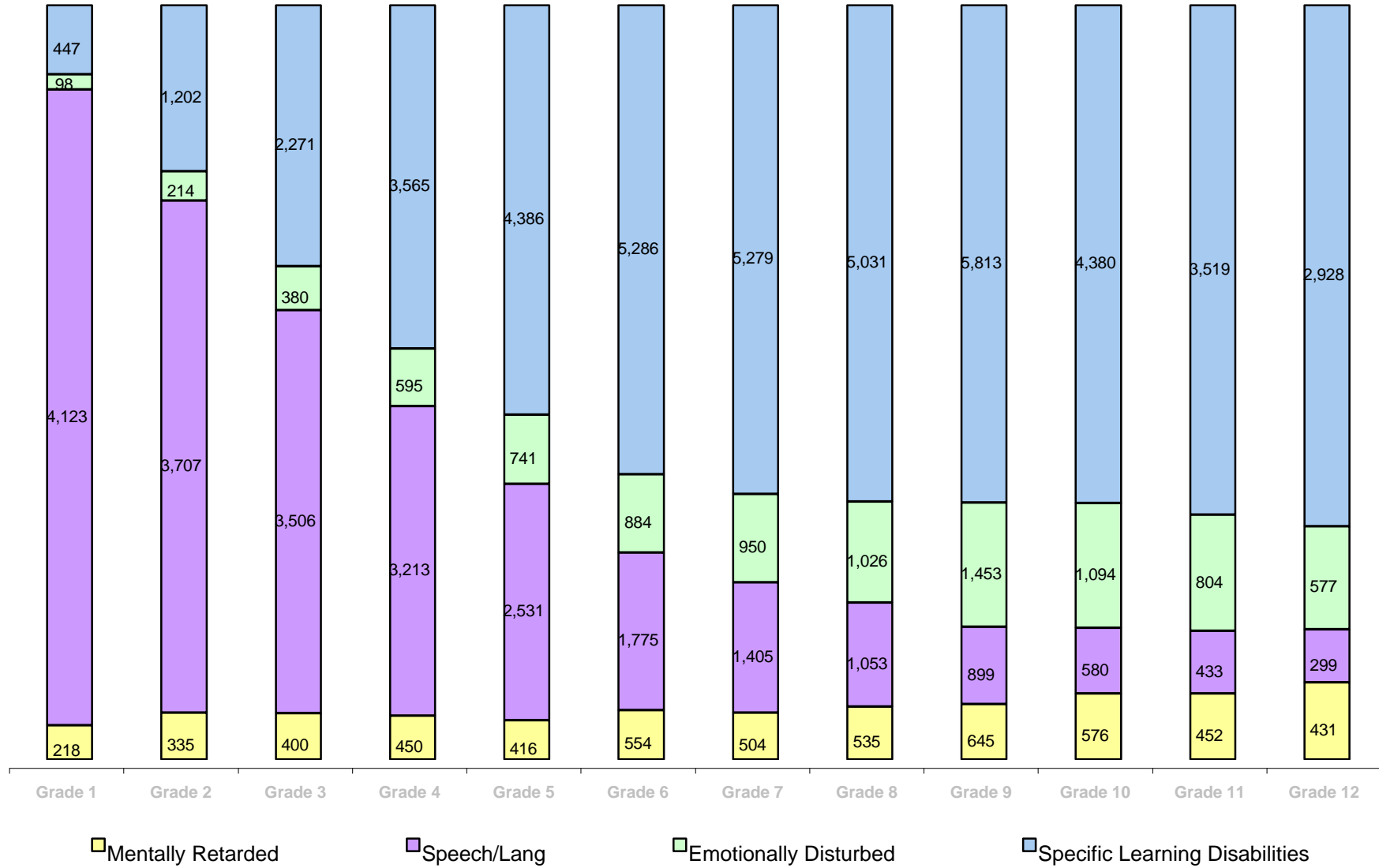

December 1, 2000

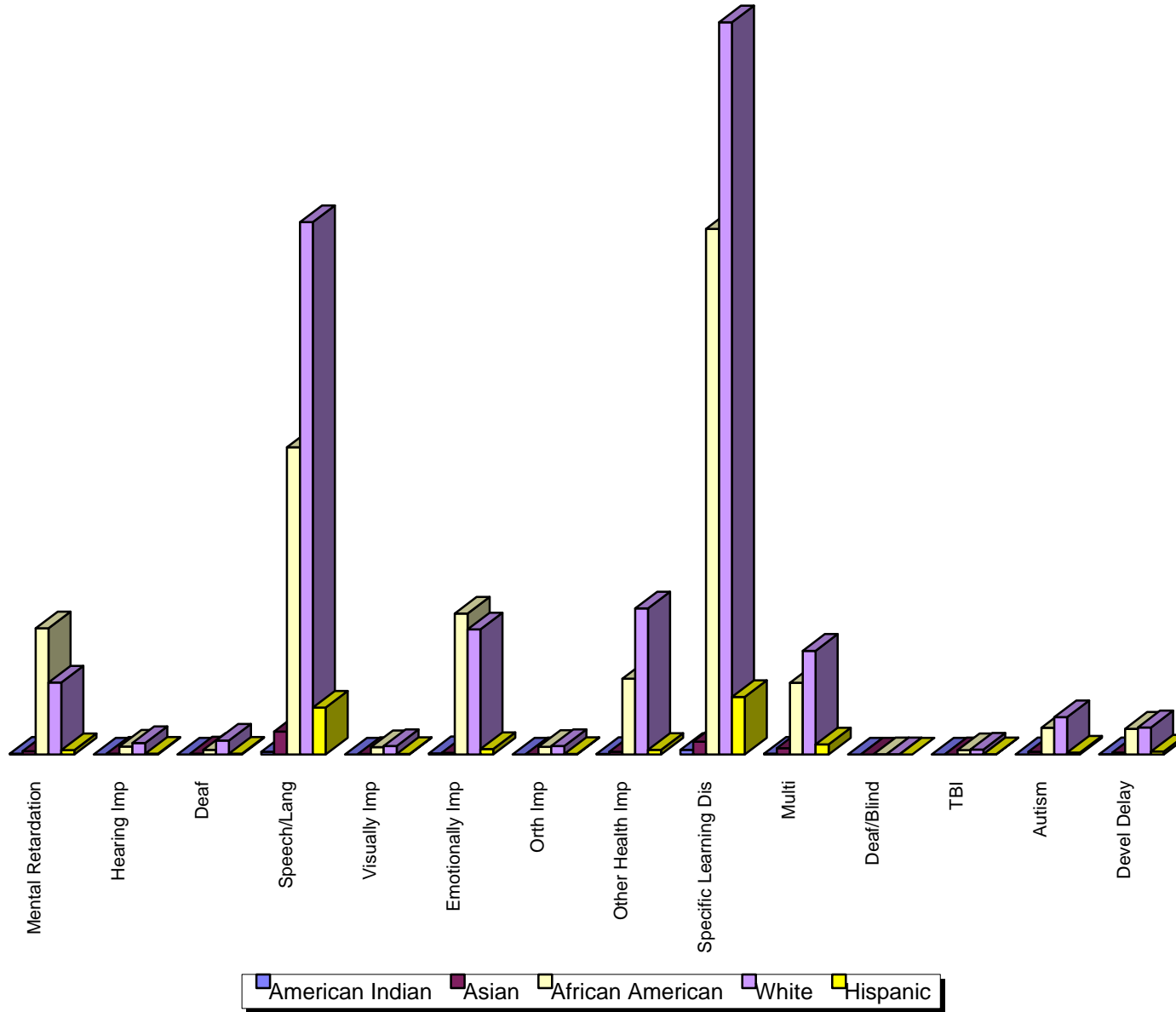
