Committee members should think about goals and details for the structure provided. Member question: Who will be on what committee? Answer: We used to appoint people to committees, but hopefully programs, services, & professional learning will stay the same with Kim and Ainsley as co-chairs, also with Awards and recognition. But with Program Improvement and Public and Community awareness, we will see who is interested in what and try to make sure the member numbers are even.

d. Criteria for Excellence Revision (ad-hoc Committee) Theresa

Ad hoc sub committee worked this summer (met twice) looking at guidelines school districts use to develop GT programs and services. Started with identification (hand out for members). Goal is to go over each part of Criteria for Excellence and add

glossary and bibliography. The document is based on extensive discussion and is being shared with GTAC to get thoughts and feedback and the committee from the summer will finish incorporating any edits. Need to draft plan - whole committee will be involved in some way whether on small committee to edit or larger committee giving feedback. If you are a new district leader and need guidelines, what can you pick up and get information - this is the document trying to create. Very specific. Can use document to leverage and support arguments.

Committee takes time to review doc alone or with a partner and to mark it up and give to the committee. And we will do the same with GT supervisors to get as much feedback as possible. Members hand in edits.

e. MEGS Update Penny

Professional Learning: every year MEGS and MSDE sponsors an annual GT conference. Anne Arundel county hosting at North County HS on October 20 (conference day for many teachers throughout the state). Keynote Dr. Brian Housand from East Carolina U. his keynote is Curiosity: Cat Killer or Mother of Invention. Will also do a session on Fake News. Also more than 30 teacher leaders throughout state will present break-out sessions. Including Jonathan Plucker from Hopkins. Penny brought paper registrations - Oct 6 deadline for paper registration, but can email www.megsonline.net. Great conference for general professional learning and if school going for EGATE status. About 400 people in attendance. At least three sessions on EGATE. Objective 4 of EGATE for schools isn't as successful for schools - re. Evaluating - so there will be a presentation on EGATE to help schools with the process.

## f. MCGATE Update Yvonne

Thanks everyone for contacting legislator about Jacob Javitz we got funding restored. Appreciates other voices helping MCGATE. Opportunity to speak up on state level - Maggy Macintosh Md. Commission on Innovation for Excellence in Education - want feedback from stakeholder; public hearings around state and opportunity to speak up on GT. October 12 at 5:00 at Baltimore Polytech. Yvonne cannot attend and encouraging people to attend. Another meeting will be in Upper Marlboro. Yvonne offers to help people to write statements. Would be great to identify ourselves as a group.

i. ESSA and Javits Grant

We received \$2.5 million Javits grant over 5 years. Bruce and Susan Spinnato had 3 weeks to write grant. Applied for last Javits grant in 2015 and did not receive the grant. The State intends to take steps to add "gifted and talented students' as an add'l student group by the end of school year 2017-2018. State will add GT as a student group will be official student group in Maryland for data collection. LEAs will now be required to collect data on gifted and talented, courses, professional learning opportunities. Includes in every section of ESSA plan under every section. Theresa question: if districts give push back this is still going to happen? Don't know the answer - this is the statement. Theresa: If any point in the next year change from intent and statement can be taken back? People at MSDE are feeling very strongly about this - based on comments from GTAC both in person and in writing. This happened because of members who made comment and testimony about the need for GT-ID, programming, professional learning. GTAC had a huge impact.

Do you see a need in year for continued advocacy. There is always a need for continued advocacy on all GT issues. Would it be appropriate for this group to express gratitude? Yes. Send Mary Gable - one individuals, thanking her and the committee and the board for advocating for this for seeing the need for supporting our GT students and families. Important to come from all different communities. Send letter from entire GTAC with positions and locations. Group letter to State Superintendent Karen Salmon.

Javits:

• \$2.5 million over 5 years

• Partnership with JHU CTE (center for technology and education) creating gateway or platform for students/parents/educators/IHEs/Researchers offer 2 way you can get info and give info. Professional learning communities embedded so people can start to talk to each other about GT education. Share ideas, thoughts.

Creating of online Gateway Portal/Platform

• Development of Stat GT Identification Guidelines; look to Criteria of Excellence; number of people working on this; GTAC and Jonathan Plucker will work with GTAC on everything.

• Superintendent workshop after develop guidelines. Will involve nationally known presenters so they can hear real deal on why we need GT education.

• 5 LEA sub-grants to create and implement professional learning and new state guidelines. Follow students because will hopefully have previously unidentified students now being identified - we will follow those students and look at pre and post scores to see how students are improving once receiving GT support. So number of research studies.

• Educator workshops.

• Research will be conducted and findings published (on portal and on the outside) Really want to help those who are not being identified.

- RAMS Center for Ecosystem Education (RAMS donated over \$100K to this center and has and continues to. Adding 3rd week next year.

All Jack Kent Cooke Funds have been exhausted from the grant given years ago. Many kids can't pay for the summer centers. One of the GTAC subcommittees will look into fundraising for these programs.

## v.Policies

1. Giftedness knows no boundaries - there are resources on website (this addressed the vision of minds)

2. Policies - Bill Knudsen was part of writing ESSA and is now at NAGC;

a. Policy at federal level now shifted to states; congress is on hiatus from elementary ed; not a lot of innovative policy making to influence - will come maybe

10 years down the road so have to prepare selves and field when debates begin again.

b. NAGC wants to protect Javits GT program (Congress put it back in after administration took it out)

c. Addressing Disproportionality; looked at research and state of the states to look for opportunities for growth. Want to ensure child as go state to state can be within environments for learning.

- i.See Me: Equitable identification is a goal. Model legislation that requires states and districts set out their i.d. Policies in equitable way.
- ii.Teach Me: Measuring learning through accountability systems that monitor progress.
- iii.Challenge me: stimulate learning through acceleration. Problems tradition of schools cautious about innovation. Parents nervous about social/emotional aspects of it. Policies need to be in place that don't lock step kids. Need to educate based on research.
