COMAR 13A.12 Licensure

(Repeal and Replace – Permission to Publish)

PURPOSE

The purpose of this item is to request permission to publish the repeal and replacement of the Code of Maryland Regulations (COMAR) 13A.12.01-.07 *Educator Licensure*. This regulatory language is aligned to the Maryland State Department of Education's (MSDE) comprehensive plan to increase the rigor and accountability of educator certification and preparation programs in Maryland.

EXECUTIVE SUMMARY

In December 2018, the SBOE approved an action plan to address the recommendations of the MSDE's

comprehensive plan to increase the rigor and accountability of educator certification and program approval. The amended regulations presented incorporate recommendations by the SBOE subcommittee, Kirwan Commission's interim report, and the State Superintendent's Educator Preparation and Certification Advisory Committee, and are designed to increase educator effectiveness in Maryland. On August 25, 2020 the SBOE granted permission to repeal and replace COMAR 13A.12.01-.07 *Educator Licensure*.

ACTION

Request permission to publish the repeal and replacement of the COMAR 13A.12.01-.07 *Educator Licensure*. After discussion, no vote was taken.

DISCUSSION

Ms. Spross provided an updated presentation on COMAR 13A.12.01-.07 Educator Licensure to the PSTEB members. Several questions were presented to Ms. Spross for clarification and understanding. One of the main concerns shared by some PSTEB members centered on the belief that the SBOE is not being provided with the appropriate information regarding PSTEB's positions. Specifically, board members shared that it is important for the SBOE to understand that specificity of their meeting discussions. This led to discussion regarding the structure of the meeting minutes and what should or should not be put in the minutes. Ms. Carla Boyd of the Attorney General's Office stated that the Open Meetings Act requires that the minutes reflect three things: Each item that the public body considered, the action that the Board took, and each vote that was recorded. Ms. Boyd also shared with the Board that if the Board would like to include other additional information, the Board will need to consider how much more information is appropriate.

Other concerns/issues discussed were:

- Internships for out-of-state teachers and the possibility of requesting a waiver for this
- The timeline associated with the promulgation process;
- Ways in which the PSTEB can communicate with the State Board, to include writing a letter, providing public comment, and requesting a joint conference meeting.
- The possibility of a staff member from the PSTEB representing the Board at the SBOE meetings.
- Establishing a subcommittee to make recommendations to the PSTEB regarding how to communicate the PSTEB's position on the proposed regulations to the SBOE.

Mr. Lloyd entertained a motion to establish a subcommittee of the PSTEB to recommend a plan for communicating with the SBOE. This plan would be considered by the entire PSTEB.

MOTION: Dr. Patricia Saelens/Mr. Louis D'Ambrosio to establish a subcommittee to develop a communication plan. The motion was approved.

(Repeal and Replace – Permission to Publish)

PURPOSE

The purpose of this item is to request permission to publish the repeal and replacement of the COMAR 13A.07.06 *Programs for Professionally Licensed Personnel*.
