### COMAR 13A.12.07.06 Programs for Professionally Licensed Personnel

Ms. Kitchen entertained a motion to deny permission to publish COMAR 13A.12.07.06 *Programs for Professionally Licensed Personnel* for public comment.

Ms. Kitchen entertained a motion to share the language in the middle column of the chart provided by Dr. Nash with the State Board of Education for COMAR 13A.12.07.06.15 Cultural Responsiveness Competencies.

Motion: Dr. Debi Gartland/Dr. Winona Taylor to adopt the language in the middle column of the chart for COMAR 13A.12.07.06.15. The motion was voted on and approved. Vote: Favor: 11 Opposed: 0 Abstain: 1

### **Discussion**

A new chart with regards to COMAR 13A.12.07.06.15 (Cultural Responsiveness Competencies) was presented to the members for discussion. The chart showed both the current and proposed language changes. The language written in blue was not included in the recommended language but the language in red appeared in both of the prior proposals. The PSTEB members decided to vote to adopt the proposed language in the middle column of this chart for COMAR 13A.12.07.06.15.

After discussion, the PSTEB members voted to deny permission to publish both COMAR 13A.12.01-.07 and COMAR 13A.12.07.06 for public comment due to uncertainty of misalignment with the Blueprint for Maryland's Future statute.

Ms. Kitchen informed the PSTEB members that Mr. Lloyd will be speaking at the State Board Meeting on March 23, 2021, on behalf the PSTEB. Mr. Lloyd will be giving the State Board an update on the PSTEB and the decisions that were made regarding the regulations. It was suggested that Dr. Nash provide comment to address the rationale for the proposed language changes regarding the cultural competencies. Dr. Nash will transmit a letter to Mr. Lloyd describing the rationale for accepting the proposed language to be shared with the State Board.

Ms. Kitchen stated that it would be best at this time to table the chart on COMAR 13A.12.01-.07 until the April meeting. Ms. Kelly Meadows suggested to the members that they read the Blueprint for Maryland's
