SUBJECT: Maryland General Assembly Legislative Update

PURPOSE:

The purpose of this item is to provide a status update of primary and secondary education-related bills that are currently before the 2019 Maryland General Assembly.

EXECUTIVE SUMMARY:

Tiffany Johnson Clark will update the members of the State Board of Education on significant legislation that has been introduced thus far during the 2019 legislative session.

Bills for State Board Discussion:

Kirwan Bill

SB 1030 – The Blueprint for Maryland's Future

Sponsor: President

Hearing: 3/6; Committee: EHE Crossfile: HB 1413 (Speaker) *Status: no movement as of 3/22*

- Establishes the Blueprint for Maryland's Future as State education policy, based on the recommendations of the Commission on Innovation and Excellence in Education.
- The Blueprint has three principles and calls for sustained and coordinated effort in five main policy areas.

• Concentration of Poverty Grant

- Establishes the Concentration of Poverty School Grant to provide grants to schools with a high concentration of students who are FRPM eligible.
- o FY 2020 and FY 2021, the State must distribute a grant of \$248,833 to each county board of education for each eligible school in the county.
- FY 2020 and FY 2021, the State must distribute to MSDE \$126,170 to fund a Director of Community Schools within MSDE.
- Requires each eligible school to employ a community school coordinator and a health care
 practitioner position and use the grant to fund these positions. If a school already has either of the
 positions, the money must be used for wraparound services.
- Requires the community schools coordinator to complete a needs assessment by July 1, 2020 to determine the needs of the community.

Compensatory Aid/Low-income Proxy

o Provides that the definition of "compensatory education enrollment count" stands until FY 2025.

Special Education

 For FY 2020 and FY 2021, requires the State to distribute \$137.5 million to local school systems for the education of students with disabilities. Also provides the percent breakdown that each local school system must receive.

• Transitional Support for Struggling Learners

- o For FY 2020 and FY 2021, requires the State to distribute specified amounts of money to county boards to provide transitional supplemental instruction.
- Requires each county board to distribute the above funds to public schools to address the needs
 of struggling learners in kindergarten through grade 3.

• Provides that when providing transitional supplemental instruction, priority should be given to literacy.

Mental Health Services Coordinator

o For FY 2020 and FY 2021, requires the State to provide \$83,333 to each local school system to fund a full-time mental health services coordinator as required in 7-1511.

• Prekindergarten Supplemental Grants

o Extends the supplemental prekindergarten grant one more fiscal year (FY 2021).

• Declining Enrollment Supplemental Grants

o Provides that the existing supplemental declining enrollment grant is extended until FY 2021.

• Teacher Salary Incentive Grant Program

- Establishes a Teacher Salary Incentive Grant Program to provide grants to county boards to increase teacher salaries to improve recruitment and retention of high-quality teachers. MSDE must administer the fund.
- o Authorizes a county board to submit an application to MSDE by July 1, 2019 for a grant.
- Requires the State to provide a grant to county boards as provided in the bill if the county board provides a negotiated and funded average salary increase for teachers of at least 3% in FY 2020 (total \$75,000,000).
- Priority should be given to increasing starting teacher salaries and salaries for teachers with less than 5 years experience.

• Teacher Collaborative Grant Program

- Establishes the Teacher Collaborative Grant Program to: (1) provide funds for collaboratives to develop state-of-the-art professional education for current and prospective teachers that reflect international and national best practices, and (2) award grants to collaboratives to develop model professional development programs.
- o Requires MSDE to administer the Program in collaboration with MHEC.
- Authorizes a county board of education or teacher prep program to submit an application to MSDE to receive a grant.
- Requires a collaborative to include at least one county board, one teacher preparation program, and one exclusive employee representative.

• Consumer Price Index Clarification

 Makes technical changes – changes the Washington-Baltimore metropolitan area, to the Washington Metropolitan Area when referencing the Consumer Price Index.

• Outreach and Training

- Performance Evaluations
- Provides that a local school system is subject to a performance evaluation conducted by the Office of Program Evaluation and Government Accountability. The evaluation may be performed concurrently with or separately from an audit conducted by OLA.
- The performance evaluation may include an evaluation of:
 - whether or not the school system is complying with law and regulations;

- an analysis of grading, standards, graduation requirements, assessments, procurement and equitable use of resources; and
- an evaluation of fraud, waste, and abuse.
- Office of Program Evaluation and Government Accountability will be established by <u>SB 640/HB</u> 1113.

Maintenance of Effort

- Provides that it is the intent of the General Assembly that increases in local appropriations to county boards above MOE should be considered part of the increased local funding required by funding formulas to be recommended by the Commission.
- IEP Study
 - o Alters the due date of the IEP independent study from September 1, 2019 to December 1, 2019.
- Extension of Commission Term and Final Report
 - o Alters the due date of the final report of the Commission to December 1, 2019. Provides that the first report was a preliminary report and the second report was an interim report.

Administrative Issues

HB 390 - State Department of Education - Employment Categories and Practices

Sponsor: Jones

Hearing: 2/12; Committee: APP Similar Bill: SB 422 (Benson)

Status: Favorable with Amendments Report by APP. Passed House Floor (99-42). In FIN.

State Board submitted a letter of opposition

- Alters the employment categories of certain professional assistants within MSDE.
- Reclassifies special appointment positions within MSDE, except those who perform a significant policy role or provide direct support to a member of the executive service, to positions in the professional or skilled service under the State Personnel Management System (SPMS).
- By July 1, 2019, MSDE must determine which employment classifications at MSDE would ordinarily
 be described as being in the skilled or professional service. Beginning on July 1, 2019, all employees
 hired by MSDE in those classifications must be hired, promoted, or transferred in accordance with the
 requirements for skilled or professional employees under SPMS.
- *Amendments: add a sponsor to the bill.*

SB 422 - State Department of Education - Employment Categories and Practices

Status: Favorable Report by FIN. Passed Senate Floor (47-0). Hearing in W&M on 3/26.

HB 87 - State Board of Education - Membership - Teachers and Parent

Sponsor: Ebersole

Hearing: 2/7; Committee: W&M

Crossfile: SB 529

Status. Favorable with Amendments Report by W&M. Passed House Floor (98-40). In EHE.

State Board submitted a letter of opposition

- This bill increases the membership of the State Board of Education from 12 to 15 members by adding 2 certified teachers and 1 parent of a student enrolled in a public school.
- For teacher members, the Governor selects a member from a list jointly submitted by the Maryland State Education Association and the Baltimore Teachers Union.
 - The teacher member may not vote on any matters that relate to appeals to the State Board regarding suspension or dismissal of teachers, principals, or other professional personnel.
- For parent members, the Governor selects a member from a list submitted by the Maryland Parent Teacher Association.
- Amendments:
 - o specify that one teacher must have experience teaching K-6 grade and one teacher must have experience teaching 7-12 grade;
 - o authorize the teacher members and parent member to attend and participate in executive sessions of the State Board; and
 - o prohibits the teacher members from voting on matters that relate to educational appeals.

HB 238 - Education - Removal of County Superintendents - Procedures

Crossfile: SB 747 (Lam)

Status: Favorable with Amendments Report by W&M. Passed House Floor (136-0). In EHE.

- Authorizes a county board to file a complaint with the State Superintendent of Schools requesting the removal of a county superintendent and specifying the manner in which a county board may file the complaint.
- Authorizes a county superintendent to request a hearing before the State Superintendent or an arbitrator.
- *Amendments:*
 - Authorize a county board in addition to the State Superintendent to remove a county superintendent;
 - Authorize the State Superintendent to remove a county superintendent if the State Superintendent provides the county superintendent with:
 - *The reason for removal:*
 - *Documentation supporting the removal: and*
 - *The opportunity to request a hearing before the State Superintendent within 10 days.*

- Authorize a county board to remove a county superintendent if the county board provides the county superintendent with:
 - *The reason for removal:*
 - *Documentation supporting the removal: and*
 - *The opportunity to request a hearing before an arbitrator within 10 days.*

Amendments: Same as House amendments.

HB 45 - Accountability in Education Act of 2019

Sponsor: Administration

Hearing: 3/7; Committee: W&M *Crossfile: SB 92 (Administration) Status: no movement as of 3/22*

- This bill establishes the Education Monitoring Unit (EMU) as an independent unit in the State. This bill also establishes an Inspector General position in the EMU.
 - The EMU is authorized to investigate whether civil rights of certain individuals are being upheld, analyze issues of child abuse and neglect, graduation requirements, assessments, procurement, among others, and report on instances of fraud, abuse, and waste.
 - o EMU may make inquiries and obtain information, hold hearings, have access to MSDE's, county board, and local school system records, and issue subpoenas.
 - o EMU must establish an anonymous tip program to report violations.
- This bill establishes an Inspector General Selection and Review Commission in the EMU.
- This bill is an emergency bill.

State Board submitted a letter of opposition

• Establishing that the State Superintendent of Schools may disapprove an appointment of a county superintendent only if the candidate does not meet certain qualifications.

School Calendar

SB 128 - Community Control of School Calendars Act

Sponsor: Pinsky and King Hearing: 1/30; Committee EHE. Crossfile: HB 437 (Ebersole)

Status: Favorable Report by EHE. Passed Senate (31-13). Passed House Floor (95-45). Passed Enrolled.

- Requires each local board of education to set start and end dates each year for public schools in the county.
- Repeals any law prohibiting a local board from beginning or ending its school year before or after a certain date
- Amendments: provide that if the bill is submitted to referendum at the November 2020 election, then a certain statement should appear in the specimen ballot. The amendments also make the bill an emergency bill.

HB 437 - County Boards of Education - School Year - Start and End Dates

HB 1078 - Education - Public School Holidays - Presidents' Day and Easter

Status: Favorable Report by W&M. Passed House Floor (120-19). EHE hearing 3/20.

- Repeals a provision of law designating Presidents' Day and the Monday after Easter as public school holidays.
- Requires public schools to devote part of the day to appropriate exercises for the observance of Presidents' Day.

HB 53 - County Boards of Education - Length of School Year - Adjustments

Sponsor: Chang

Hearing: 2/14; Committee: W&M

Crossfile: SB 131 (King)

Status: no movement as of 3/22

- This bill clarifies that a county board of education to extend the length of the school year for *any* reason up to 5 school days beyond June 15 without the approval of the State Board *or any other entity*.
- This bill is an emergency bill.

HB 1043 - Education - Required Number of School Days or Hours

• Alters the requirement that public schools be open for at least 180 days and a minimum of 1,080 hours during a 10-month period in each school year to require that the schools be open for at least 180 days or a minimum of 1,080 hours during a 10-month period in each school year.

SB 1006 - Education - Opening Public Schools Before Labor Day - Public Local Laws and Referendum

Hearing: no hearing set as of 3/22; Committee: Rules

 Authorizes a governing body of a county to adopt a public local law that exempt the public schools in the county from the Starting the Public School Year After Labor Day Executive Order if the governing body submits the public local law to a referendum.

Hearing: no hearing set as of 3/22; Committee: Rules

HB 587 - Education - Public School Holidays - Veterans' Day

Sponsor: Wilson

Hearing: hearing canceled; Committee: W&M

Status: Unfavorable Report by W&M. Withdrawn by Sponsor.
Requiring Veteran's Day to be a public school holiday.

Curriculum/Assessments/Grading

HB 371 - State Board of Education - Financial Literacy Curriculum - Graduation Requirement

Sponsor: Walker

Hearing: 2/14; Committee: W&M *Status: no movement as of 3/22*

MSDE submitted a letter of information

- Requires the State Board of Education to develop curriculum content for a half-semester-long course in financial literacy.
- Requires each local board of education to implement the curriculum in every high school under the board's jurisdiction, and a student must complete the course in order to graduate from high school.

HB 1138 - State Board of Education - Financial Literacy Course and Exam - Graduation Requirement

Sponsor: Shoemaker

Hearing: 3/8; Committee: W&M *Status: no movement as of 3/22*

MSDE submitted a letter of information

- Requires the State Board of Education to develop curriculum content for a ½ credit course in financial literacy on or before July 1, 2020.
- Requires each county board of education to implement the financial literacy curriculum content developed by the State Board in public high schools beginning in the 2020-2021 school year.
- Makes passing a course in financial literacy a graduation requirement.

SB 416 - Education - Curriculum - Holocaust and Genocide Unit (Lessons of the Holocaust and Genocide Act)

Sponsor: Kramer

Hearing: 2/13; Committee: EHE *Status: no movement as of 3/22*

State Board submitted a letter of opposition; MSDE submitted a letter of information

- Requires public middle schools and high schools and nonpublic middle schools and high schools that receive State money to include in the curriculum a unit of instruction on the Holocaust and genocide.
- Requires the State Board of Education to develop guidelines for instructional content on the Holocaust and genocide that is age-appropriate.
- Encourages nonpublic middle schools and high schools that do not receive State money to include in the curriculum a unit of study on the Holocaust and genocide.

<u>HB 567 - Education - Public and Nonpublic High Schools - Organ and Tissue Donation Awareness</u> Instruction

Sponsor: Queen

Hearing: 2/21; Committee: W&M *Status: no movement as of 3/22*

- Requires each county board of education to provide age-appropriate instruction on organ and tissue donation and registration as part of the personal and consumer health curriculum in grades 9 through 12 in public schools by the 2020-2021 school year.
- Encourages non-public high schools to provide age-appropriate instruction on organ and tissue donation and registration.

SB 954 - Education - Public and Nonpublic High Schools - Organ and Tissue Donation Awareness Instruction

Sponsor: Nathan-Pulliam

Hearing: 3/13; Committee: EHE *Status: no movement as of 3/22*

<u>HB 631 - High School Graduation Requirements - Student Service - Fire-Fighting Training and Volunteer Hours</u>

Sponsor: Adams

Hearing: 2/21; Committee: W&M *Status: no movement as of 3/22*

• Providing that if a student is required to complete hours for student service in order to graduate, then fire–fighting training and volunteer hours may be used to satisfy the student service requirement.

<u>HB 985 - Public High Schools – Science Credit Requirement – Computer Science and Computer Programming</u>

Sponsor: Rose

Hearing: 3/8; Committee: W&M *Status: no movement as of 3/22*

 Authorizes a student to satisfy one science credit by completing a credit in computer science or computer programming.

HB 1211 - Education - Foreign Language Requirement - Computer Programming Language Courses

Sponsor: Rose

Hearing: 3/8; Committee: W&M *Status: no movement as of 3/22*

- Authorizes county boards of education to authorize students to satisfy a State or county middle or high school foreign language requirement by completing a course in computer programming language.
- Requires the State Board of Education to adopt regulations that establish the computer programming language courses that fulfill the requirements of the bill.

HB 1224 – County Boards of Education – Computer Science Courses

Sponsor: Rose

Hearing: 3/8; Committee: W&M

Status: Favorable Report from W&M. Passed House Floor (138-0). Hearing in EHE on 3/27.

• Requires each county board to submit to the State Board of Education the total number of computer science classes offered, among other things, beginning in the 2022-2023 school year.

<u>HB 1019 - State Board of Education - Public High School Students - Assessments and Graduation</u> Requirements

Sponsor: Guyton

Hearing: 2/28; Committee: W&M

Status: Favorable with Amendments Report by W&M. Passed House Floor (135-0). Hearing in EHE on 3/27.

- Requires the State Board to administer an assessment no later than the 11th grade to determine whether a student is ready for college level classes in ELA and math to a sample of high school students in the State during the 2019-2020 school year and prohibits the State Board from using the assessment to evaluate a student in any way for graduation from high school.
- Requires the State Board to administer the above assessment to all high school students in the State during the 2020-2021 school year and prohibits the State Board from using the assessment to evaluate a student in any way for graduation from high school.
- Amendments
 - o strike first reader version of the bill.
 - o provide that the State Board may require a passing score on a standardized test to graduate from high school and authorize the State Board to use the assessment to determine up to 20% of a student's final grade in a course in the subject of the assessment if that test has previously been administered statewide for at least one year.

HB 948 – Education – Advanced Placement Examination Fees – State Payment

Sponsor: Washington

Hearing: 2/28; Committee: W&M *Status: no movement as of 3/22*

- Requires county boards must pay the AP exam fees for public school students in the county beginning in the 2019-2020 school year.
- Requires the State Board of Education to reimburse the county board for the AP exam fees paid in the prior fiscal year.

SB 757 - Primary and Secondary Education - Assessments - Limitation of Administration (One Day in May Act)

Sponsor: Klausmeier

Hearing: 3/6; Committee: EHE

Status: Unfavorable Report by EHE.

- Alters the method for determining the amount of time devoted to the administration of federal, State, and locally mandated assessments.
- Limits the amount of time that is devoted to the administration of these assessments to not more than 1 school day and a school day in May.

SB 544 - Education - No-Zero Grading Policy - Prohibition

Sponsor: Salling

Hearing: 2/13; Committee: EHE *Status: Unfavorable Report by EHE.*

• Prohibits a county board of education from establishing a no-zero grading policy.

Miscellaneous

SB 617 - Free College, Career Skills, and Youth Apprenticeship Act of 2019

Sponsor: Rosapepe

Hearing: 3/6; Committee: EHE Status: no movement as of 3/22

- Establishes the Career and Technology Education Committee. The Committee is an independent unit within the Governor's Workforce Development Board, and the State Superintendent is a member. The Committee must build a framework for providing CTE to Maryland's students.
- Requires county boards of education to report to the State Board the number of students who complete the College and Career Readiness standard adopted by the State Board beginning in FY 2022.
- Requires the State Board to adopt an assessment method that measures whether a student is ready for community college-level coursework in ELA, mathematics, and science by the end of 10th grade starting in the 2020-2021 school year.

- Requires the State Board to periodically review the assessment and adjust it to global standards and State workforce needs. It must also conduct research to analyze whether NCEE standards are comparable to global standards.
- Requires the State Board to coordinate and consult with MHEC and the Governor's Workforce Development Boards to carry out the charges of this legislation.
- Requires the State Board to adopt regulations for the required provision of counseling services to assist students in choosing a post-CCR pathway.
- Requires the State Board to give high school graduation credit for programs recommended by the Skills Standards Advisory Committee and approved by the Career and Tech Education Committee.

HB 733 – Primary and Secondary Education – Community Schools – Established

Sponsor: Ebersole

Hearing: 2/28; Committee: W&M Crossfile: SB 661 (Washington) *Status: no movement as of 3/22*

- Establishes community schools in the State as a public school that establishes a set of strategic partnerships between the school and other community resources that promote student achievement, positive learning conditions, and the well-being of students, families, and the community.
- Provides that the purpose of a community school is to help students and families overcome the in-school
 and out-of-school barriers that prevent children from learning and succeeding over the course of their
 lives by having an integrated focus on academics, health and social services, youth and community
 development, and familial and community engagement.
- Requires a community school to have:
 - o active family and community engagement;
 - a community school coordinator (CSC) to coordinate support programs that address out-ofschool learning barriers for students and families;
 - o expanded and enriched learning time and opportunities provided after school, during weekends, and in the summer that emphasize mastering 21st Century skills;
 - collaborative leadership and practices that empower parents, students, teachers, principals, and community partners to build a culture of professional learning, collective trust, and shared responsibility;
 - o a parent teacher organization or a school family council; and
 - o a community school leadership team.
- Requires the community school leadership team to conduct an assessment of needs and assets as part of the planning year that precedes implementation of the community school plan. The assessment of needs must include a baseline analysis of the needs and assets of the students, family, and community.
- Authorizes a community school leadership team or community school coordinator to solicit the assistance and support of community partners.
- Requires a local school system to provide public funding to a community school if it offers at least two of the following types of interventions: (1) academic services; (2) parental involvement programs; (3) physical and mental health services; and (4) community involvement programs.
- Amendments
 - o provide that the community school coordinator is responsible for developing and implementing the plan for the community school; and
 - o strike the community school leadership team and everything that was required of them, including a school needs assessment.

SB 661 - Primary and Secondary Education - Community Schools - Established

Sponsor: Washington

Hearing: 2/28; Committee: EHE Crossfile: HB 733 (Ebersole)

Status: Favorable with Amendments Report by EHE. Passed Senate Floor (46-0). Hearing in W&M on 3/21.

Amendments:

HB 950 - State Department of Education - School Discipline - Data Collection

Sponsor: Washington

Hearing: 2/28; Committee: W&M *Status: no movement as of 3/22*

MSDE submitted a letter of information

- Requires MSDE to publish all discipline-related data on the Maryland Report Card website at the State, local, and individual school level.
- Requires MSDE to disaggregate and publish any data related to disproportionate disciplinary practices.

HB 1208 – Board of Restorative Practices in Schools – Establishment

Sponsor: Washington:

Hearing: 2/28; Committee W&M *Status: no movement as of 3/22*

- Establishes the Board of Restorative Practices in Schools
- The State Superintendent of Schools and the President of the State Board of Education would be members of the Board.
- Amendments: Alter the membership of the Board of Restorative Practices.

SB 653 - County Boards of Education - Establishing Innovative Regional Schools - Authority (Cross-County Attendance to Achieve Efficiency Act of 2019)

Sponsor: Hester

Hearing: 2/26; Committee: EHE

Status: Favorable with Amendments Report by EHE. Passed Senate Floor (46-0). Hearing in W&M on 3/21.

- Establishes regional community schools that offers special courses and admits students from different school systems based on an MOU between the LEAs.
- Provides that the State Board and State Superintendent do not have approval authority over the creation of these schools.
- Amendments
 - requiring the MOU to be subject to the approval of each county governing body that is a party to the MOU; and
 - provides that the collective bargaining agreement that governs XYZ will govern working conditions at the innovative regional school.

HB 356 - Primary and Secondary Education - Nonpublic Schools - Required Information

Sponsor: Patterson

Hearing: 3/7; Committee: W&M

Status: Favorable with Amendments Report by W&M.

• Requires each nonpublic school to submit certain information to MSDE on or before September 1 of each year.

- Authorizes the State Board of Education to revoke the certificate of approval or church exempt registration of a nonpublic school that fails to submit required information.
- Requires a nonpublic school to submit certain information if the State Board requests it.
- Requires MSDE to make public the accreditation, curricula, and courses of study information provided on MSDE's website.
- Requires the State Board of Education to adopt regulations.
- Amendments
 - Strikes the first reader version of the bill.
 - Requires MSDE to provide to the county agency responsible for permitting and the local fire marshal (1) a list of nonpublic schools in the county that have been issued a certificate of approval by the State Board, and (2) a list of nonpublic schools that have provided church-exempt registration form and other documents required by the State Board.

- Employer must report relevant information collected to the Department, and can request information on the applicant's eligibility for employment and certification status.
