11:10 Maryland State Department of Education Updates, Jason Semanoff

- Publications
 - O The Adapted Physical Education Guidebook was updated this spring
 - Coming soon
 - A revised version of the PE Framework. -Updating the glossary, sample assessments and list of critical elements. No changes were made to the standards, outcomes, or indicators.

- Title IX Guidance and Recommendations for Physical Education Classes.
- Individualized Action Plan (IAP) Guidance
- Physical Education Participation Memo
- Secondary Health Education Training Modules
- Maryland High School 3Rs Lessons
- Online Adapted Physical Education Course (APE)
 - o Teachers can earn 3 CPD credits.
 - o 7 people enrolled for the summer '22 course.
 - O MSDE will continue to offer one APE course per semester using CANVAS.
- Health Education webpage
 - MSDE's communications office and leadership team updated the health education website to echo the purpose of the State Framework.
- Updating the State standards for health education and physical education
 - O SHAPE America owns the copyrights to both the health education and physical education standards.
 - Separate task forces were created and began the process of updating them.
 - Maryland has representation on both task forces.
 - When published the Council will have a chance to review and discuss the next steps.

- Moved to Johns Hopkins Bloomberg School of Public Health
- Maryland Wellness Policies and Practices Project ended in 2020
 - o "Coffee Table Books" will be mailed this summer
 - o Still available to support LWP implementation
- Wellness Champions for Change
 - The project ended early due to the pandemic
 - The online course is still available and free to Maryland teachers
 - o NEW Students-Led Wellness Teams
 - Sharing curriculum with interested school districts, nationally

11:55 Maryland Department of Health Update, Kristi Pier

- Safe routes to schools
 - LEAs should work with their local health departments → reach out to Kristi (kristi.pier@maryland.gov) for more info.
 - Future potential funding
 - Example projects bike park, access to safe walking routes between and within communities and schools. Jason will share more info when it becomes available.
- Walk to school day is October 5th; this is also Walk Maryland Day.

12:00 Council Updates, Dr. Grant & Christiana Walsh

- Health education discussion
 - O SHAPE America owns the copyrights to the National Health Education Standards and has created a diverse task force to update them
 - The National Consensus on School Health is a separate group not aligned with the CDC.
- Best practices for accessing ESSER funds
 - FCPS Money has already been spent. Not sure if additional funds will be made available. Was able to host several professional development sessions for elementary school teachers on suicide awareness and sexual assault.
 - O City Schools Schools received the money. It was originally earmarked for arts and athletics. Was able to provide a 1-pager on different ways the funds could be used. Principals spent the funds at their discretion. Reminded H/PE teachers that they have to ask their principal to access the resources. Strong advocates were able to acquire widdle equipment, a Lu interactive playground, etc. Removing barriers was the goal. Having a seat at the table was critical.

- FCPS some funds were used to provide access to safe Drinking water. Some schools bought bottled water. Others installed bottle filling stations. The goal is to have at least one bottle filling station in every building.
- O HCPS Purchased a set of pedometers for all middle and high schools and an additional set that can rotate through the elementary schools. The pedometers help with goal setting. The program will be fully implemented next year.

• .5 to 1.0 HE transition

- O AACPS Is calling their high school courses Health A and Health B. Health B is in process. Will write the curriculum next year.
- O HCPSS Will pilot "Health 2" in multiple schools next year. Working with the health education professional learning network to develop exemplar units and lessons.
- O MCPS Offering paid Tier 1 training this summer (9 hours). Calling their courses Health A and Health B. Offering all honors courses unless certificate bound. Equity was brought to the forefront. Schools will be offering Health B this Spring as a pilot. MCPS Board of Education will consider the adoption of the Framework in June
- HCPS Piloting the courses next spring. Will LEAs hire new folks to teach these courses or will PE teachers be repurposed?
 - MCPS some students will likely be pulled from PE electives. Was given 10 open contracts. Staffing pipeline concerns. Total staffing for the entire district will be lower because student enrollment is down, necessitating fewer teachers. Make sure potential HE teachers are aware of triggers that may occur from teaching the HE content.
 - AACPS The students will choose which elective it comes from. Principals are posting health educator positions. Professional development will be needed to deliver the content.
 - HCPSS Hiring more health education teachers. Lots of administrative support to do so. Elective enrollment increased in PE to match the HE half-year course.
- O WCBOE "Health Through Wellness" will be taught in the gymnasium. Losing .5 credits of PE. Will use this course as an opportunity to fill the loss in physical activity due to the decrease in required PE credits. Looking at purchasing new health education textbooks and editing the curriculum next year. Will run this course in all schools.
- o PGCPS Will offer Health 2 in the fall for 11th and 12th graders. Some students will, unfortunately, have to take both Health 1 and Health 2 at the same time.

• Letter to MSDE

O The co-chairs will draft a letter to the State Superintendent advocating they hire a highly-qualified health education specialist with full benefits ASAP
