### **Updates from Member Organizations and Stakeholders**

- MSDE: 2024 U.S. Department of Education Green Ribbon Schools, Lutherville Laboratory and the Waldorf School of Maryland, were presented their awards in Washington, D.C. on July 10 and attended sessions and events throughout the week with other honorees
- MDE: MCCC Just Transition Working Group had kick off meeting and will be discussing
  job training and may have connections to K-12 relevant to OLP; next meeting on July 26
- Upcoming events: Defensores de la Cuenca <u>reef building on July 13</u> at Sandy Point State
  Park, and camping at Assateague and Rocky Gap State Parks in July and August
  (information can be found on <u>Defensores' website</u>); <u>DNR Es Mi Parque</u> events in July,
  August, and September

- MELAN: upcoming higher education convenings (to include HEEL) and regional meetings this summer, partnering with MAEOE Green Centers, GenThrive EcoRise Landscape Assessment to launch
- MAEF: Maryland Agriculture Educators Conference held July 7-10 where agriculture and environment teachers earn professional development credits. About 50 teachers gathered at Middletown HS and the surrounding community for multiple sessions. This could be an opportunity for OLP and its members next year. The next conference will be July 7-9, 2025 in Western Maryland, and the following one July 6-8, 2026 on the Eastern Shore.
- MAEOE: Recently appointed to the <u>MCCC ECO Working Group</u>. MAEOE is launching <u>new website</u>, which features a <u>calendar</u> that partners can add events to via online form.
   Certified Maryland Green Schools were recognized at MAEOE Youth Summit on May 30 with about 70 schools participating.
- MACCEC Conference held June 25-27 and included examples of Climate Action Plans (Prince George's County Public Schools) and climate education policy

#### **Procedures and Bylaws Overview**

  - OLP Procedures and Bylaws are currently being developed by DNR and MSDE utilizing guidance from EO 01.01.2024.15, bylaws, procedures, and governance documents from existing committees in Maryland, Maryland statute (i.e. Open Meetings Act), and other standard procedures (i.e. Robert's Rules of Order)
  - OLP Procedures and Bylaws will be presented once finalized and approved by MSDE and DNR legal counsel
