Ms. Nancy Perkins and Ms. Alaina Jackson Mackell from the Office of Teaching and Learning gave a detailed presentation on the Science of Reading.

Discussion Items

Special Education Coursework for Specialists and Administrators

- Ms. Meadows gave a summary and explained the current requirement for the special education course for Specialists and Administrators. There was a question proposed as to what the board's options were regarding the special education requirement. She explained the anticipation of revisiting this requirement because of the number of concerns received regarding the barriers this requirement. Some feel that this requirement may cause major barriers in recruitment with educators in these areas.
- Ms. Meadows referenced a memorandum from a previous meeting with 4 options to remedy those concerns.
 - 1. Do nothing to change requirement
 - 2. Amend the regulation by taking that requirement out
 - 3. Remove required course from initial requirement and require course at renewal
 - 4. Expand the use of the temporary professional license to specialists and administrators
- The Board agreed that they should take another look at all the options available to remedy the barriers of recruitment.
- Most of the board agreed that they would have concern with waiting for renewal to present the special education course

• The board agreed that the most comfortable solution to addressing the special education requirement for specialists and administrators would be option 4.

{To expand the use of the temporary professional license to specialists and administrators.}

- Ms. Meadows stated that she would come back to the board in October with potential language for the board to vote on to publish.
- Mr. Hornbeck encouraged the board to go back and talk to their constituents to get feedback.
