# Maryland letei no le paw letei naw aa nuinah **le a mingkhainah tuahning cang hnisa nah**

Maryland letei, nyheh pakheh chungka cy tei, pungtlang tling singcongnah letei kenah naw a nui napaw caita co, a voikheh nah leta cozo tei a hmingkainah a tuanah paw ca uh kha a nga hmasaw taw a nge.

Ma ahmingkhainah ca uh chung le co, Disabilities Education Act (IDEA) and the Code of Maryland Annotated Regulations (COMAR) tapaw tei a zatuapaw no le paw a nawnui nah kong paifiangnah vytei kha a tei.

No le paw naw nuinah le a hmingkhainah kong cianah cauh sahlo sangkheh caiteh, no le paw le single khe, a hmingkhainah kong thawngpang caitah a ho maw or zele tamaw tapaw thawngpang kha pe a cang he. All local

Education Agencies (LEA) le Public Agencies (PA) tapaw tahei pungtlantling lypaw sing congnah le hnihrang pawle, no le paw le naw aa nuinah paw sahlo a fiang hrang pawtah chungka a bongtu raihretu saya he kha a nui cy he.

Chungka ta no le paw le naw nuinah caw a hmu hrinhring kha a nge: Ahmingkhainah cauh (Procedural Safeguards booklet ) na sawtei caw pungtlantling lypaw sianging leta kesa a nge caco, a congcai kungkheh hlai leta, cozo leta na sawtei konglang phuangnah na tua napaw ca kha a nge aa, IEP le no le paw nawnah cung letei na sawtei caw a hiasa pawta biachawnah a tua ca co, a cunglang tei a hmingkhainah cauh a nge aa.

Maryland phunglang tei a tingpaw co, sianging zuiphung leta, ingdawng sangkheh cungtei a hmangpaw rei a ung caco, IEP sianging nyheh konglang caw paleh pa a cang he. No le paw le naw nuinah kong sahlo cauh, caw rei phing<sup>25</sup> paleh paw a cang, maco YOU tube le MP4 taita zong ngekhy a cang he. No le paw le naw nuinah kong sahlo cauh, khuahmunah le thuinah langtei a changby paw ingchungkha ta zong heikhy a cang he.


### IEP phu ta na sawtei sianging a kenah pawkong kha, IEP phu ahia paw a tuapah thlu hlai leta, na ngakhy

Sianging cacawng nadang a thlaihlai leta, no le paw leta ahiapaw le a caikha a hnithai a nge, ma sahlo vytei he a teita, pafiangnah (identification), cuithlenah(evaluation), hminghmawchinah (placement) le tingpaw tlang patling nah le ungnahkong (accommomodation) le service sahlo vytei a teita a ningcai kha a pafiang he nge.

### Sianging nyheh le chungkha kong sahlo vytei caw, zawpui hni lyta chiakha a nge

No le paw leta a sawtei le sianging akenah paw record kha recview tuanah naw a nui, ahmang lypaw a ungtah a rawhpaw a ung caco, parai pakaw hreupaw ta nawnah a tua khy. LEAs le PAs vytei tahei sawtei le a record parainah paw kong leta no le paw leta zuirhang paw, zuiphung le tuanah dang (procedures) kha nui he.

Sawtei le pungpa kong palang pahlai leta no le paw le hnawtlanah kha a nge hmasaw aa, a cawngtu paw or ahiaut lypaw kong seh taly co. Nyheh kha petle tei ca(document)popo kha sianging kenah letei thainah record cangthlu be, zekhata acang zongta, ma thawngpang caw, zawpui le palang paw cang be, no le paw le hnawthlakuinh a tei lyta a lailang chuapa paw cang be. Sianging nyheh pakhe te thainah record caw, siang kenah a chuasy khy a tlapaw cai leta ro pa a cang he, ma record a rohlai le co, no le paw leta ma ca(document) a heikhy mai he. Zawpui sianging kenah leta a palongnah thinah leta, no le paw hnawthlanah a tei lyta tuapa khy a cang he, ma sianging nyheh a record kha. Zawpui sianging taitah private(pungpa) sianging lang a palong napaw tei, a hia paw record caita co, no le paw le hnawthlanah kha a nge hring hring a.



## **Zalong teitah sianging kenah paw hming pachingnah caita sianging taita a mai pepa paw kha a sohkhy or bong heinah a tuakhy.**

LEA le PA taitei a phi cungle tei hmingpaching nale test sanah a tuapaw sahlo cung leta chungkha ta alung atling lypaw cang caco, sianging taite hmingpachingnah a tuatu he le LEA le PA taitei tangka pepaw a cang lypaw he, pungpa tei a tuatu hei kha tuasa nah naw a nui he. Ahluita sing congnah letei evaluation a tuapaw heta a hringpaw a sopah co he, maco sianging nyheh IEP phu taita a mahle caining teita sangsangkheh palehnah a ung ly caco, chungkha ta IEE tapaw a zalong paw evaluation a tuatu he kha a naw khy he. Chungkha taitah IEE letah nawnah a tua cangco, LEA le PA tah ning30 hlaile tah pale nah a tua hringhring aa, assessment caitei tangkha bongnah hnawtlakhuinah ta maw, or khingtlenah (evaluation) a dawcakinah napaw ta a phichua a duly napaw kha naw nah tuah ta.

## **A sawtei le caw, siikan anui ah taatha rawchy nah a nui.**

LEA or PA taitah siikan kong leta dangtahnah sangsangkheh a tua paw a cng ah co, IEPs letei sianging nyheh sahlo caita, IDEA tapawta sianging nyheh sahlo kivai napaw le tuanah sahlo vtei kha a pe hlu he. Slanging kenah naw a hmu ciapaw le kenah pawta a tua leimei paw le, kenah naw a hmu lypaw LEA le PA tei pungtlangtlng kypaw singcongnah caita ahnikhui paw vtei ta, sianging nyheh kivainah (protection) caw a hmu aa.

## **Na sawtei le cawtei., sianging kenah kongle biachawnah naw caw nuikhy leimei.**

Maryland letei, pungtlang tling lypaw sianging letei biachawnah naw caw, na sawtei kung 18 a tling taita zong no le paw cung leta a unga. Hming a cangning cunglela a ngatpaw a ung, machung le co, Pungtlang tling lypaw sianging letei biachawnah naw caw, sianging nyheh langkha palong khy a cang mai aa. Mahlu vtei biachawnah khynah kungkhua a cangnah le a palongnah paw ta biachawnah a tuahlai le a bapui paw tuahrang paw tuaning cang(process) a ungtaw.

## **Pungpa(private) sianging leta a sawtei lecaw a ning dunah ta a chiathlang zong he ta, sianging taitah tangka pesa pawta a rawchai be he.**

IEP phu taita a chiana paw kha a lungting ly ah co, chungkha taita pungpa(private) sianging leta a sawtei lecaw a chia khy thlang e, nateita LEA le PA ta a sawtei le sianging kenah mai kha ama pepa taatah rawchaipaw cang be. Chungkha ta piatana a cangpaw phisin nah kongkha a hni aa, tahchungnah ta, parainah(mediation) le a sawtei le chianah letei a pacangnah le thlawzongnah phisin nah kha a hni khynah.

## **No le paw le anui lypaw caita no le paw le kha a thlangpa khy he**

Pungtlang tling lypaw sing congnah leta no le paw le a nui lypaw sianging nyheh aa ung ah co, LEA or PA ta no le paw hrata a hmingkhai hrang paw hekha a hoi pakhy he. Sianging nyheh caita mepui caita rai a hrepaw he (social worker ) he kha, no le paw caita hmang nga be. LEA le PA ta hlangpapaw no le paw kha tingtan (training) a pe he, maco no le paw caitei raipe a cang paw kha MSDE leta thuisanah a tua a.



## **Pungtlang tling lypaw sianging sekhuinah dang hlupui leta, hnawthlakhuinah le hnawthlakhui ly nah paw.**

Ma sahlo tuanah letei, hnawthlanah tuacia paw kha, zeining caipo ta chungkha ta a rokaw khy mai aa.

## **Na sawtei caita a tlapaw zawpui sianging, maily ta kenah, singnah congnah letei chianah, hmingchuinah, le pafiangnah kong sohlo vytei leta na hnaw a tlaly paw vytei phisinnah (resolve).**

Sianging a kenah dang kong leta, raihre hrui sahlo ta a caicai le co hnawtla lynah a nui khy mai. Hnawtla lyna sangsangkheh a ung caco, chungkha taita a railang letei tuaning cang sahlo vytei kha pacang hreunah naw a nui a: parainah or tlangtlanah (mediation) coza le report tuanah sahlo kha thuinah naw anui a.

## **Parainah or tlangtlanah:**

Lungting lyna vytei leta tlangtlanah caw, zawpui thuih lyta tuahpaw hming a cang. Tlanglatu chaw taco, raihrehruipaw aa rawnah le pakheh cytei a tongpaw piatana kha lungfiang hrangpaw ta abong he. Tlanglatu chaw tei a rai caw, raihrehruipaw khata piatana acang paw kha a rua ta, a phi sangsangkheh chuakhy napaw caita a bong he. Tlanglatu chaw caw thluidangnah nui be, mah caw a phi a cang taatah chinghe kha rai cang be.

## **Biacenah paw thuinah (Due Process Hearing):**

Biacenah paw thuinah caw, Uktu langtei biacetu tei tuateipaw, le tuaningcang a cang. Phuhning ta a biachuakuipaw a pacynah paw ta, tetteh (witnesses) le evidence kha a chuakhui aa. Coza biacetu a rai caw, tetteh le bia a reipaw kha nge cang ahka, piatahna phisin khyna paw caitei biachaw nakha a chuakhui aa.

## **Coza leta phung ning teita report nah (Formal State Complain):**

Pungtlang tling lypaw sianging letei pungpa caittei a hia paw cungle tale or Maryland State law or regulations leta nawbuuanah a ung tatah no le paw ta a zing caco, Ma report na caw, Maryland letei sianging langta raihrenah (MSDE) tapw le ta ape aa. Ma report nah a chia khy taico, MSDE taita chekhlae nah le nawbuuanah a ung tata maw tapaw kha a tua aa. ahia caco nawbuuanah parainah kha a chinng he.
