**PERMISSION TO PUBLISH** 

#### **Purpose**

The purpose of this item is to request permission to publish amendments to COMAR 13A.16 *Child Care Centers* and COMAR 13A.17 *Child Care – Letters of Compliance* related to group size and staffing requirements for school age children.

### **Regulation Promulgation Process**

Under Maryland law, a state agency, such as the State Board, may propose a new or amended regulation whenever the circumstances arise to do so. After the State Board votes to propose such a regulation, the proposed regulation is sent to the Administrative, Executive, and Legislative Review (AELR) Committee for a 15-day review period. If the AELR Committee does not hold up the proposed regulation for further review, it is published in the Maryland Register for a 30-day public comment period. At the end of the comment period, Maryland State Department of Education (MSDE) staff reviews and summarizes the public comments. Thereafter, MSDE staff will present a recommendation to the State Board of Education to either: (1) adopt the regulation in the form it was proposed; or (2) revise the regulation and adopt it as final because the suggested revision is not a substantive change; or (3) revise the regulation and re-propose it because the suggested revision is a substantive change. At any time during this process, the AELR Committee may stop the promulgation process and hold a hearing. Thereafter, it may be recommended to the Governor that the regulation not be adopted as a final regulation or the AELR Committee may release the regulation for final adoption.

### **Executive Summary**

## Proposed Regulation: School Age Children

The proposed amendments pertain to the maximum group size and mandatory training for staff in centers that serve school age children. Currently, a group of school age children (i.e., children younger than 16 years old and attending a public or nonpublic school in grades kindergarten or above) must have a staff/child ratio of 1 to 15 and a maximum group size of 30. Under the proposed amendment, a center may utilize a maximum group size of 45 when staffed by at least one teacher, one assistant teacher, and one aide. A parallel amendment is not necessary for letter of compliance facilities because staff are not required to be qualified as teachers in the same way. As to staff training, groups that include infants, toddlers, or preschoolers must have at least one staff member who is certified

in approved first aid and CPR for every 20 children. That is the standard across the board under current regulation. Under the proposed amendment, however, groups consisting exclusively of school age children must have at least one on staff member who is certified in approved first aid and CPR for every 30 children. These changes provide additional flexibility to centers and letter of compliance facilities that serve school age children while ensuring appropriate supervision and care based on the age groups present.

### Stakeholder Engagement

MSDE met with a School Age Workgroup, where these amendments were first suggested, as well as the Office of Child Care (OCC) Advisory Council to discuss this proposed regulation and receive feedback. The OCC Advisory Council is a public body, created by statute, that is responsible for providing guidance and recommendations related to child care services and regulations in Maryland. The Council serves as an advisory body to MSDE, offering insights and expertise on matters concerning early childhood education and child care programs. Its primary focus is to ensure the well-being, safety, and quality of child care services within the State, making recommendations for policy changes and improvements in the child care system as needed. The stakeholders consulted were supportive of the proposed amendments.
