#### **Background**

The Blueprint for Maryland's Future is a historic opportunity to transform education and accelerate student achievement for students across Maryland. The Blueprint requires each LEA to develop an Implementation Plan consistent with the Comprehensive Implementation Plan adopted by the AIB. Implementation Plans shall describe the goals, objectives, and strategies that will be used to improve student achievement and meet the Blueprint for Maryland's Future recommendations for each segment of the student population. MSDE must recommend approval of each plan to the AIB and each LEA's submitted plan must be approved by AIB.



### The LEA Blueprint Implementation Plan

- Education Article §5-404 requires each LEA to develop an Implementation Plan consistent with the Comprehensive Implementation Plan adopted by the AIB.
- LEA Blueprint Implementation Plans shall describe the goals, objectives, and strategies that will be used to improve student achievement and meet the Blueprint for Maryland's Future recommendations for each segment of the student population.
- Each submitted LEA Blueprint Plan must be approved by the AIB.
  - MSDE must recommend approval of each plan to the AIB.
- LEAs submitted their Initial Blueprint Implementation Plans in March 2023.
- In 2024, LEAs submitted their second Blueprint Implementation Plans in two parts:
  - Part 1 plans (Systemwide Blueprint Implementation) were submitted on March 15, 2024.
  - Part 2 plans (Initiative-specific questions) were submitted on May 1, 2024.

   LEAs are asked to respond to in their 2024 Blueprint
   Implementation Plans
- The Part 1 submission question (Systemwide Blueprint Implementation) asks LEAs to provide an overview of how they are holistically approaching Blueprint Implementation across the district and how the initiatives in each pillar work together.
- The Part 2 submission has 23 specific questions, where LEAs provided detailed responses about specific programs and components of the Blueprint.

#### **Collaboration Between MSDE and AIB**

- MSDE and AIB staff built an integrated, combined review process, sharing responsibilities in each step of the process.
- A team of 30 MSDE and 6 AIB staff members served as plan reviewers and participated in a multi-day collaborative review process to ensure rating consistency and accuracy. Rating consistency across reviewers was of paramount importance.
- Each component of each LEA Blueprint Implementation Plan was reviewed by at least five reviewers across AIB and MSDE.
- The reviewers rated the submitted plans against the published success criteria and provided feedback for improvement.
- Upon completion of independent reviews of each LEA's submission, MSDE and AIB staff convened to discuss any ratings variances on the Criteria for Success and validate the final ratings and requests for plan revision.

### **Highlights and Common Themes from Submitted Plans**

- After reading the Blueprint Implementation Plans from each of the 24 LEAs across Maryland, a few common themes emerged across multiple LEAs:
  - o Dedication to establish or expand partnerships with other organizations and institutions
  - Prioritization of stakeholder outreach and involvement
  - Increased collaboration of LEA staff across different district offices and schools
  - Expanded access to opportunities such as Pre-K, Career Counseling, Dual Enrollment, etc.
  - Continued discussions around financial decisions and resource allocation
  - Focus on identifying and developing additional supports for students who have not yet met the CCR Standard

### **Next Steps for Revisions and Approval**

- In the past week, the combined MSDE and AIB requests for revision were sent to the individual LEA Superintendents and Blueprint Coordinators, in two groups of 12 LEAs each.
  - For each criterion where the LEAs did not meet the published Criteria for Success, guidance on how to revise their response to meet the stated criteria was provided.
- The LEAs are asked to review the feedback and requests for revision and submit updated responses within about 3 weeks of receiving their results, if not sooner.
- MSDE and AIB staff are available to meet with each LEA so all involved can ensure a common understanding of the feedback provided, expectations of the revisions needed, and the process for resubmitting the updated responses.
- When resubmitted, MSDE and AIB staff will review the updated submissions to determine if
  they meet the Criteria for Success and then either provide additional guidance to the LEA or
  recommend to the AIB Board that Parts 1 and 2 of the Implementation Plans have met all
  Criteria for Success.

#### **Ongoing Support and Guidance**

- Blueprint Implementation is a continuous and ever-evolving process. The work does not stop when the Implementation Plans are approved.
- MSDE and AIB are dedicated to providing the guidance and support needed to each LEA across Maryland to achieve the Blueprint goals.
- Some of the AIB and MSDE guidance and support initiatives that are forthcoming include:
  - AIB Phase II Technical Assistance Grant, with the focus areas of
    - Resource Allocation/Reallocation and Strategic Budgeting
    - Extension of Phase I Grants for Strategic Facilitators
    - Career Ladder for Educators
    - College and Career Readiness Pathways (CCR)
    - Prekindergarten Expansion in a Mixed Delivery System
  - CCR Supports Guidebook
  - Expert Review Team visits, focused on literacy and math instruction
  - Community Schools Guidebook
  - Ongoing collaboration opportunities between LEAs and State agencies
