### **Purpose**

The purpose of this item is to provide an update on MSDE's and AIB's plan for monitoring the implementation of the Blueprint's tasks by each of the 24 Local Education Agencies.

### **Executive Summary**

As specified in the AIB Blueprint Comprehensive Implementation Plan, LEAs and State agencies submit Blueprint Implementation Plans, detailing their completed actions and plans for future actions over the 10-year implementation period. These plans are to be submitted in two phases. LEAs submitted their Phase 1 plans in 2023 and 2024. Today, MSDE and AIB will discuss the structure of Blueprint implementation monitoring for calendar year 2025.

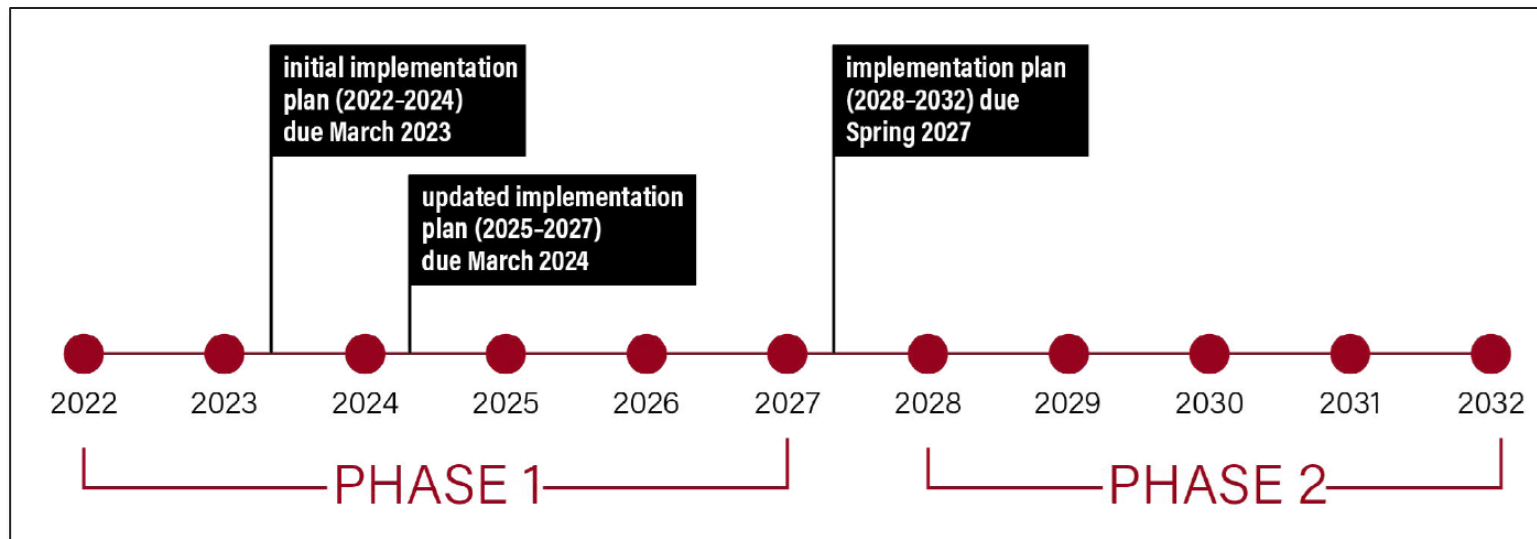

# LEA Blueprint Implementation Plan Submission Timeline

- As specified in the AIB Blueprint Comprehensive Implementation Plan, LEAs and State agencies will submit Implementation Plans covering the 10-year implementation period in two phases.
- Phase 1 plans were submitted in two parts during the spring of 2023 and 2024, covering Blueprint implementation tasks that have been or will be undertaken from FY 22-27.
- Phase 2 plans will be submitted in spring 2027, covering Blueprint implementation tasks in FY 28-32.

# Blueprint Implementation Monitoring for 2025

- Aligned with the submission timeline shared in the AIB Blueprint Comprehensive Implementation Plan, LEAs and State agencies will submit their next written implementation plans to the AIB in spring 2027 for Phase 2 of implementation.
- During the interim period until the Phase 2 Plan submission, AIB and MSDE will continue to monitor implementation at the local level each year.
- Implementation monitoring for 2025 will include conferences with local superintendents about each LEA's progress implementing the Blueprint, as described in their Phase 1 plans.

# Implementation Monitoring Conferences

- Implementation monitoring conferences will focus on areas such as:
  - Implementation successes and progress related to priority areas across the five pillars
  - Progress in meeting the aligned metric targets adopted by the boards
  - Implementation challenges and any necessary changes in implementation strategies
- LEAs will have the opportunity to share local data demonstrating implementation progress
- AIB and MSDE will seek input from LEAs on the content, scheduling, and other logistics of these conferences before finalizing any requirements.
  - The planning process will continue through this Winter/Spring with the conferences to be scheduled for late Summer/early Fall 2025.
- LEAs and State agencies may annually update their Phase 1 plans, as needed.
