Purpose

The Maryland State Department of Education (MSDE) Comprehensive Arts Education Branch is eager to introduce itself and the team's work to the State Board of Education during the month of March, which is nationally recognized as Arts In Our Schools Month. We will provide updates to the Board on key arts education projects and share a summary of recently submitted COMAR Certifications for Fine Arts Programs.

Background

The Comprehensive Arts Branch is comprised of members who have joined MSDE since July 2023. Prior to that time, MSDE had a gap in state-level arts leadership staffing for over a year and a half. As a result, it has been a number of years since an MSDE arts representative has provided updates to the State Board about trends, priorities, and projects related to arts education in the state.

In addition, COMAR 13A.04.16.03 mandates that every five years, beginning in 2019, Maryland's local superintendents must certify to the State Superintendent of Schools that the instructional programming within grades PK-12 meets, at a minimum, the requirements set forth in Regulation 13A.04.16.01. The Comprehensive Arts Branch will share a summary of the certifications submitted in 2024.

Executive Summary

The Comprehensive Arts Branch presentation to the State Board will cover the following items:

- 1. An overview of the Comprehensive Arts Branch, including a data snapshot of arts educators and offerings in Maryland public schools;
- 2. A summary of COMAR 13A.04.16.03, Certification Procedures for Fine Arts Instructional Programs, and the information submitted by local education agencies in 2024;
- 3. An informational update on Secondary Arts Pathways for students to be college and career ready in any of the five arts disciplines (dance, media arts, music, theatre, and visual art);
- 4. A brief description of the many ways in which MSDE celebrates and elevates Maryland's student artists and performers, during March and throughout the year.



COMAR 13A.04.16 – Programs in Fine Arts

.01 Requirements for Fine Arts (Dance, Media Arts, Music, Theatre, Visual Art) Instructional Programs for Grades Prekindergarten—12.

A. Each local school system shall:

(1) Provide an instructional program in fine arts each year for all students in grades prekindergarten—8 as follows:

(a) Within the prekindergarten—5 grade span, students shall have experiences in the fine art forms of dance, media arts, music, theatre, and visual art; and

(b) Within grades 6—8, students may specialize in one or more of the fine art forms of dance, media arts, music, theatre, and visual art; and

(2) Provide an instructional program that enables all students in grades 9—12 to meet graduation requirements, and to select from among fine arts elective courses of dance, media arts, music, theatre, and visual art that will prepare them for post-secondary education and careers.

§B, C, D, and E require <mark>dedicated time</mark> allotment for arts, alignment to <mark>UDL principles</mark> and Maryland State Fine Arts Standards, provision of <mark>curriculum</mark> materials, and universal student participation in §A.



Local Challenges to Secondary Arts Instruction

- Scheduling large ensemble classes (band, chorus, orchestra; larger dance or theatre programs)
- De-prioritization of arts by school leaders and college and career counselors
- Staffing diverse arts courses in rural/remote LEAs

Proposed Secondary Arts Pathway Overview

- 4 credits in 9th-12th-grade arts courses (dance, media arts, music, theatre, visual art)
- 3 credits should be in the same arts discipline (dance, media arts, music, theatre, visual art)

At least one of the following is required in addition to the arts course requirements above:

- Participation in county-, region-, and/or state-wide exhibition, performance, or audition, where applicable
- Completion of a capstone arts project, performance, or exhibition
- Earning an arts-aligned industry-recognized credential and/or completing a high school level registered apprenticeship or internship

Arts diploma seal/endorsement earned upon graduation
